# Programmatic Adjustments Due to Covid-19

# Drop off and Pick Up

- Drop off will begin 15 minutes before the session begins.
- We are not able to provide early or late care.
- We will also not accept late drop offs or any early pickups.
- Parents/guardians will stay in their cars at all times. Parents cannot stay on campus during programming.
- CDC guidelines recommend limiting the number of adults who drop-off/pick-up campers. Families should designate one adult to do all transportation per family.
- Parents/Guardians will be required to wear masks while on campus even when in their cars.
- If your child will be absent from camp we require an email stating why they are absent.

# Social Distancing and Face Masks/Coverings

- All CDC guidelines for social and physical distancing will be implemented when appropriate
- Masks will be worn by all staff.
- All children must bring their own face masks/coverings to camp. Face masks will be required for children when indoors.
- Camp groups will have no more than 15 kids per group. Due to Covid-19 guidelines, groups are required to be static. Group requests will not be accepted. Due to Covid-19 guidelines no group changes can be made under any circumstance. There will be no large group gatherings.

### Snack/Water Bottle

- Your child may bring an easy to eat NUT FREE snack with them(i.e. pretzels, goldfish)
- All children must bring a refillable water bottle every day.

### Activities

• All activities will take place outside except if there is unsafe weather conditions. Child groups will then have designated indoor spaces including for bathrooms and storage areas.

### **Daily Health Screenings**

- All children and staff will have daily health screenings before entering programming. Parents are required to perform a pre-camp health check before bringing their child to camp.
- Temperature Check Temperatures will be taken upon arrival. Any child with a temperature of 99.9 degrees or higher will not be permitted to attend camp until they have been fever free for 72 hours without the use of fever reducing medication.
- Any child experiencing the following symptoms will not be permitted to attend camp: fever, sore throat, cough, runny nose, or lethargy.
- If your child develops a temperature greater than 99.9 degrees Fahrenheit or is showing signs/symptoms of illness (cough, sore throat, runny nose, lethargy) while at camp, they will be quarantined/isolated at the health center. Parents/guardians will be contacted and required to pick up their child (and siblings) as soon as possible. All Parents/guardians must have at least two





emergency contacts that will be able to pick up their child/ren in the case of them being isolated.

#### Hand washing/Sanitizing

- Hand washing or sanitizing will be required for all children and staff before and after each activity.
- Public spaces as well as camp materials/equipment will be disinfected throughout the day.

#### **Protecting Public Health**

 In the instance that a child/staff member is diagnosed with COVID-19 while enrolled in camp or within 14 days of being at camp, contact tracing will be used to identify those children & staff that are required to quarantine. The children/staff who were in immediate contact with the infected child/staff must self-quarantine for 14 days from the date of notification. A credit will be issued to those families affected. All buildings with exposure will close for at least 72 hours for additional cleaning and sanitizing.

#### **Covid-19 Exposure and Positive Cases**

- Any staff or child who have been in contact with a COVID positive individual within 48 hours prior to the onset symptoms should be tested. If the person was asymptomatic, all persons who had contact with the individual 48 prior to their positive test result should be tested.
- Staff or children with potential, extended exposure will be asked to be tested. Per current policy, positive children or staff will need to return home and not return to campus until the DOH required time frame for quarantine has passed.
- If an employee or child has had close or proximate contact with a person with COVID-19 for a prolonged period of time AND is not experiencing COVID-19 related symptoms, the employee or child may return to campus upon completing 14 days of self-quarantine.
