Please confirm arrangements for each weekend **by no later than 12 pm on the Monday before the Home Weekend begins.**

Whether or not your child takes medication, **both pick up and return will be at the Health Center.** The Health Center staff will call to have your child either brought over from or returned to their dorm. This allows us to better and more safely monitor children's comings and goings from campus.

We ask that you return your child to campus between 2:00-5:00pm on their scheduled day of return. This is to ensure the appropriate staffing is on duty, continue to closely monitor who is on campus and facilitate a smooth transition back into the dorm program for your child. We will be strictly enforcing our return timeframe by not allowing unexpected early returns. If this presents a problem for you, please be sure to discuss with your child's Social Worker.

If your child takes CSE bus transportation, please confirm pick up/drop off times and location with the school district and your child's Social Worker.

We appreciate and thank you for your continued cooperation. Please feel free to contact this department with any questions or concerns.

We are now offering Green Chimneys transportation every designated home weekend and you are welcome to take advantage of the below listed transportation that we offer.

Please note: Effective Friday 1/26/2024 Green Chimneys will be offering an additional drop off location to Catskill NY. Please see information below for time/location This location will be re-evaluated in 30 days for convenience and usage. Notify your child's social worker directly if you intend on utilizing this location.

We require that you be at the scheduled meeting place on time. **Buses are not permitted to remain at the meeting places past the scheduled departure time.** Children not picked up by the scheduled time must be returned to the campus to ensure the child's safety.

For the return to Green Chimneys, please wait with your child until the bus arrives and be sure to check with staff before leaving your child.
